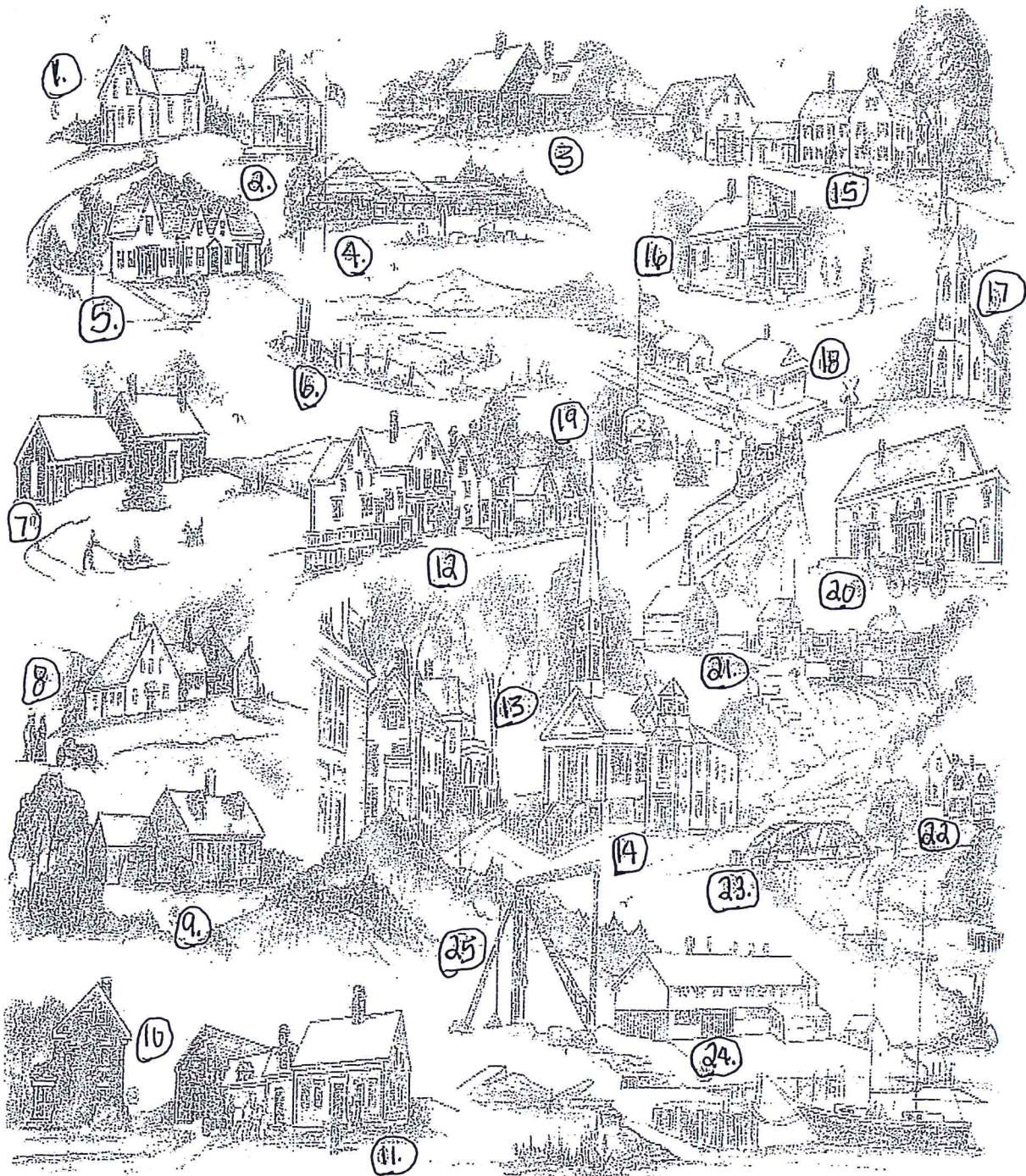


2020 was a year unlike any in our lifetimes. Our state and nation dealt with unprecedented challenges--the coronavirus pandemic, ensuing economic fallout, and a prolonged, heavily divisive campaign season each took a significant toll on all of us. The worst part? In order to protect each other, we had to face these challenges in isolation. But a new year represents new possibilities; a chance to take stock of what we're grateful for and focus on the opportunities in front of us. As we reflect back on 2020, we will remember heartbreak and loss – but we cannot forget the shining rays of hope that broke through the darkness, reminding us all that better days are ahead.

Throughout the pandemic, my top focus has been on bridging the partisan divide in Washington in order to deliver desperately-needed relief for Maine people. Joined by colleagues last March, we pushed for bipartisan negotiations to produce a strong bill that helped fellow Mainers, businesses, and institutions weather this storm. In the weeks and months after the *CARES Act* passed, our team stayed in close contact with people throughout the state to determine how we should adjust our response to best support our citizens. Unfortunately, the aid provided by the *CARES Act* lapsed without Congressional action, leaving too many families and businesses in limbo. I never stopped pushing for a bipartisan relief bill and, after extensive negotiations, we ended the year on a good note by breaking the gridlock and passing new relief legislation. This new bill isn't perfect; in fact, it should just be the start our renewed response. As we enter 2021 with a new administration and new Congress, we must fight for additional legislation to help restore stability to our working families and rebuild our economy and public health infrastructure.

In the midst of this crisis, Congress did manage to accomplish a few successes that will outlast this awful pandemic. Among these was the *Great American Outdoors Act*, a bipartisan bill which was enacted into law in August 2020 and will help address a \$12 billion backlog at our national parks so future generations of Americans can enjoy these beautiful lands and create lifelong memories. Also, as we learn more about the recent hacks of our nation's networks, there is help on the way: 27 of the cybersecurity recommendations made by the Cyberspace Solarium Commission – which I co-chair with Republican Congressman Mike Gallagher– made it into this year's defense bill. While there is no guarantee that these provisions would have prevented the massive hack, they will certainly improve our cyber defenses.

Despite the challenges, I'm hopeful for the future. Vaccines are being distributed across our state – starting with our healthcare heroes, who have sacrificed so much throughout this unprecedented catastrophe and deserve our eternal gratitude. If there can be a silver lining from these challenges of 2020, maybe it will be this: I hope that, in the not-so distant future, we will be able to come together physically and we will be reminded of our love for each other. We have differences, without a doubt. But as Maine people stepped up to support each other, we saw again and again that our differences pale in comparison to the values we share. We are one state, and one community – and there is nothing we cannot or will not do for each other. Mary and I wish you a happy and healthy 2021. We can't wait to see you soon.

Dear Friends:

It is an honor to represent Maine in the United States Senate. I am grateful for the trust the people of our State have placed in me and welcome this opportunity to reflect on 2020, an incredibly challenging year for Maine families, small businesses, and communities.

When the pandemic struck, our country faced the specter of an overwhelmed health care system and devastation to our small businesses and the millions of people they employ. I immediately worked with Republicans and Democrats to pass multiple laws allocating approximately \$3 trillion to respond to this public health and economic crisis, including more than \$8 billion directed to Maine to support testing, schools, the economy, and other purposes — that is nearly double Maine's annual state budget.

I am especially proud of the bipartisan Paycheck Protection Program (PPP) I co-authored. This program has provided three out of four Maine small businesses with nearly \$2.3 billion in forgivable loans, which has helped sustain more than 250,000 Maine jobs. I have met thousands of Maine small employers and employees in all 16 counties who are surviving because of the PPP. As one small business owner told me, the PPP provided “exactly what we needed at exactly the right time.” The PPP also allowed employers to maintain benefits, such as health care, during this challenging time. Another round of PPP is needed to sustain small businesses and their employees.

While the pandemic continues across Maine, our nation, and the world, I thank the first responders, health care professionals, teachers, grocery store employees, factory workers, farmers, truck drivers, postal employees, and so many others who continue to stay on the job during this difficult time. With the deployment of the first vaccines, better tests, and the incredible speed with which these life-saving responses were developed, I am hopeful we can emerge from this crisis in the next few months.

While providing relief to American families was my focus throughout 2020, other accomplishments include the passage of the Great American Outdoors Act, which provides full funding of the Land and Water Conservation Fund and addresses the maintenance backlog at our national parks, forests, and wildlife refuges. As Chairman of the Transportation Appropriations Subcommittee, in 2020 alone, I secured \$132 million to improve Maine's roads, bridges, airports, buses, rail, ferries, and seaports. Finally, as Chairman of the Aging Committee, I led the reauthorization of the Older Americans Act, which funds programs that improve the well-being, independence, and health of our nation's seniors and their caregivers, and I authored laws to reduce the cost of prescription drugs and protect individuals with Alzheimer's disease.

As the end of 2020 is approaching, I have cast more than 7,535 votes, never having missed one. In the New Year, my focus remains to work with colleagues to find common ground on policies to help support the health and safety of Mainers and the safe, responsible opening of our communities. If ever I or my staff can be of assistance to you, please do not hesitate to contact one of my state offices. May the coming year be a successful one for you, your family, your community, and our state.

Dear Friends,

I hope this letter finds you safe and well. I know that this year has been challenging for many of our communities. In the midst of these challenges, it remains a privilege to represent you, and I appreciate the opportunity to update you on what I have been working on in Congress for the people of the Second Congressional District.

The coronavirus pandemic has made this year an especially difficult one. We've seen the struggles of small businesses, workers and families, hospitals, and states and towns. COVID-19 has been a serious threat to public health that requires a comprehensive, ongoing response. In March, Congress passed the largest of three bipartisan pieces of relief legislation, the *Coronavirus Aid, Relief, and Economic Security (CARES) Act*. The *CARES Act* was a \$2 trillion economic relief package to provide immediate assistance for some of those hit hardest by the pandemic. While an important start, many of the programs and benefits created by the *CARES Act* were set to expire by the end of 2020 at a time when COVID-19 cases were on the rise. That's why in late December, Congress passed another bipartisan bill to provide COVID-19 relief to small businesses and hospitals, the unemployed, and families struggling to put food on the table. However, the action Congress took at the end of 2020 cannot distract from its failure to act sooner. The unwillingness of many members of Congress to accept compromise throughout the fall left many Mainers struggling and led to a rushed process that produced a bill with serious flaws. In 2021, Congress needs to step up, come together, and lead the country through this pandemic and get our economy back on track.

There are a few bright spots that came out of the work done by Congress this year. As a member of the House Armed Services Committee, I helped advocate for a national defense bill that would include important priorities for American national security, Maine shipbuilders, and servicemembers and their families. The legislation authorizes a new DDG-51 Arleigh Burke-class destroyer to be constructed at Bath Iron Works and helps BIW compete for new work by encouraging a new multi-year procurement process for the DDG-51 Flight III. This funding bill also makes permanent new federal guidelines proposed by Senator King and me to allow Gold Star Families free admission to national parks and other federal lands.

I've been working to improve mental health services for veterans for years, and I led the Maine delegation's effort to address the need for long-term mental health substance abuse treatment for veterans in our state. This past fall the Veterans Administration announced we were successful. Construction starts next year on a new, 24-bed facility at Togus that will ensure Maine veterans won't be sent out of state to receive residential care for substance use disorder and associated mental health issues. This is one result that I am especially proud to deliver for my fellow Maine veterans.

As I reflect upon what I am most grateful for this year, I am especially glad to be able to share that my wife Izzy and I are expecting a baby in 2021. We are excited about this new addition to our family and look forward to the blessings ahead.

This period is challenging for Mainers as we all take steps to limit the spread of the coronavirus, protect our families and our communities, and lean on each other to withstand this pandemic and economic hardship. My staff and I stand ready to assist Mainers as we work through these challenges together. I look forward to continuing to work on your behalf in 2021.

Citizens of Waldo County,

The Members of the Waldo County Sheriff's Office are proud to serve the citizens of our great County. We want to thank the members of the public for their continued support. We are a full-service Sheriff's Office providing Law Enforcement, Corrections and Civil Paperwork Service to folks who live, work and visit Waldo County.

2020 was a year different from any other. The Covid-19 pandemic has made providing Law Enforcement and Corrections services very challenging. The killing of George Floyd in Minneapolis has impacted how our Nation views the Law Enforcement profession and how the services we provide will be delivered and regulated moving forward. Locally, we have continued to enhance our collaboration with the Knox County Sheriff's Office with a new inmate boarding agreement and further sharing of resources resulting in savings of hundreds of thousands of dollars to county taxpayers.

Our patrol division handled nearly 8,400 calls for service in 2020. These calls included all types of incidents from murders, domestic violence, robberies, burglaries, thefts, child abuse, sexual abuse, drug overdoses, and much more. The drug abuse epidemic continues to ravage our citizens and cause much of the crime in our county. The patrol division also conducted 1,491 traffic stops throughout the county in an effort to increase traffic safety on our roads and highways.


Our Corrections Division continues to excel in the operation of the Maine Coastal Regional Re-entry Center serving 46 residents in 2020. These are men who were nearing the end of their term of incarceration. Our many programs assist them with their integration back into society as productive and contributing citizens. During their stay at the re-entry center, residents provided 4,455 hours of community service throughout Waldo County. This translated to a savings in labor costs of \$53,461 to citizens and non-profit agencies. Residents also provided more than 173,000 pounds of fresh vegetables to local food pantries and those in need from the County's Garden Project overseen by Waldo County Commissioner William Shorey. The residents also paid \$8,928 dollars in room and board to the County.

The seventy-two-hour holding and booking facility processed 649 persons who were arrested in Waldo County by all the law enforcement agencies serving our County. If a person who has been arrested cannot make bail within 72 hours, he or she has to be transported to the Knox County Jail in Rockland by our Transport Division. Our average daily population of Waldo County prisoners held at the Knox County Jail was 21 men and women. This along with bringing prisoners to court and medical appointments, generated 310 transports with our transport division, traveling more than 50,000 miles in 2020.

Our Civil Service Division served 1,030 sets of legal paperwork all over the County in 2020.

It has been an honor for all of us to be of service to the citizens of Waldo County in 2020. We look forward to a safe and productive 2021.

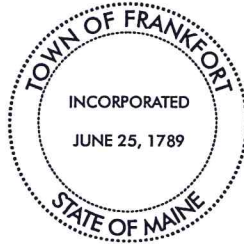

This past year we went through some crazy times. With the Annual Municipal Election and Meeting not being until July last year, we had a late start with road work.

Upon approval from the residents of Frankfort, we borrowed \$1,000,000.00 to repair and pave town roads. Even with the late start with requesting bids for paving and contractors with other obligations, we were able complete the road projects that we set out to do.

The roads that we original set out to do, Averill Street, Old Belfast Road, Black Hill Road, Town Hill Road, Treat Point Road, Lake Road, Adams Road and Mt. Waldo Road all have been repaired with ditching, culverts, paving, and/or shoulder work. Plus, we were able to complete shoulder work on the Marsh Stream Road and Hamm Road.

Also, on last year's municipal ballot the residents of Frankfort voted to eliminate the Town High Department and privatize plowing/sanding and road work and at the special town meeting, August 17, 2020, the town voted to sell all highway equipment and to use the funds of the sale of equipment for road work. All equipment was sold except for the 2008 International plow truck. The truck is up for sale, just looking for a buyer!

This year's road work plan is to cut back trees from the sides of the roads, ditching the shoulders of roads that are not done yet, and repair the upper part of the Swanville Road.

In 2020 our department responded to 69 emergency calls. Nine of those calls were mutual aid calls. If you have an emergency please remember to dial 911.

2020 has been a very different year for everyone due to the Covid-19 pandemic. Because of this most of the year we were unable to get firefighters together to have meetings and training sessions. We had to purchase extra personal protective equipment and learn new practices at emergency scenes. We also canceled our annual plant sale last May. As of March 1, 2021 our plan is to have our annual plant sale this year May 6-8 at our station. We are hoping for a huge turnout this year to make up for last year.

I want to personally thank everyone that volunteered their time and equipment to help us work on and around our station or made donations to us without putting any burden on taxpayers. There are a lot of man hours that goes into training, fighting fires, accident scenes, and maintenance on the building, equipment and trucks as well as fundraising which is greatly appreciated.

We received another \$2000 Maine Municipal Grant to help with the purchase of four more new air pack bottles.

We would like to thank all our fire department members and their families, surrounding fire departments, Maine Forest Service and the citizens and businesses of Frankfort and other surrounding towns for their continued support. We would like to thank everyone who supports our fundraisers, especially our annual plant sale that is held in May.

We are still in need of new members who would like to join our fire department. Please let one of our department members know if you have any interest in becoming a member or stop by when we are at the station. There are many different jobs people can do to help at an emergency scene or around our station.

Burning permits are available at Wilson's Country Market, from Jeffery Anderson at 745-0213, Joe Watson at 223-5266 or online at www.wardensreport.com. Special thanks to Wilson's Country Market for doing burning permits. Remember burning permits are required by law to do any open burning. We would like to remind everyone to post their address number on their house or business and near their driveway so emergency responders are able to find your home or business in the event of an emergency. It's also the law.

The West Frankfort Fire Department members are continuing to train on a regular basis to provide the best service we can for the residents of Frankfort. We are keeping up on our first aid and CPR certifications thanks to the Searsport Ambulance Service.

It is becoming more difficult to recruit volunteer fire fighters. We are asking people to give up their time from work and families for training and calls. It takes a certain type of person to ask them to run toward danger instead of away. Fires are a lot more hazardous than 20 or 30 years ago, with all the chemicals in the building materials and home furnishings, not to mention the illegal drugs and loaded weapons. All of these things require more training. These situations create the need for better fire fighting gear and equipment.

Turnout coats and pants are required to be replaced every 10 years or sooner if damaged. All self contained breathing apparatus (SCBA) needs to be flow tested annually by a certified dealer. SCBA bottles require hydro testing every 5 years with a 15 year end life on each bottle. All fire hoses need to be tested annually. Driver training needs to be done annually. Annual driving records need to be done. Every fire engine needs to have pump tests done annually. Each fire fighter that wears an SCBA needs medical clearance annually (depending on age) before wearing SCBA.

After a fire when trucks return to the station tools need to be cleaned, wet hoses need to be replaced with dry hose. Trucks need to be readied for the next call. These are some of the things that need to be done in addition to monthly meetings and monthly trainings in addition to annual Bureau of Labor Standards training.

Last year the fire department responded to structure fires, grass and woods fires, automobile accidents, smoke alarm calls, chimney fires, lift assists and CPR assist for the ambulance.

The West Frankfort Fire Department thanks everyone that has donated in some form to help the fire department. It is greatly appreciated.

We are always accepting new members to join our team and if interested contact West Frankfort Fire Chief or one of our members for an application.

We also have smoke detectors available if anyone needs one. In light of the three lives lost to three separate fires in a week we urge everyone to make sure you have working smoke detectors, they do save lives.

What a crazy year this has been! From last November to this January we saw record numbers of clients, and then the pandemic hit Maine. The cities and larger rural pantries saw huge increases in clients. Our clients actually decreased as stimulus money filled some of their basic needs. Now as unemployment funds dry up we see a turn around with 30 families visiting last Wednesday. We are open at the Victoria Grant Center at the end of Park Drive in Winterport, Wednesdays, 9am to 10am, or until the last one in line is served.

Our volunteers are mostly Seniors with at least one family member with health setbacks, so we have to be very careful. Our clients drive up and stay in their cars. A volunteer greets them and informs the volunteers inside. A week's basic groceries are brought out to the loading table. Clients place their groceries in their cars with help from a volunteer. This year we served 134 families made up of 145 individuals. Over 3000 bags of food were carried home. Please let your neighbors who need food help know about us!

Your good wishes and prayers are very appreciated. Donations are most welcome! Please make your checks payable to the Neighbor's Cupboard. We are a 501c3 non-profit organization.




