Veterans Exemption forms are available at the Town Office for eligible Veterans.

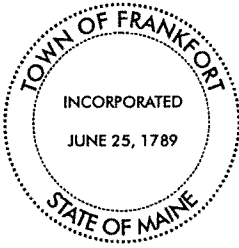

The town has identified several illegal junk yards in town, and will be perusing legal action on these with our code enforcement officer, lawyer and DEP.

The town of Frankfort is continuing to work with working with Prospect, Stockton Springs and Winterport as a joint internet committee, now known as the 1A Waldo County Broadband Coalition. The committee is actively pursuing other grants and opportunities. Representing Frankfort on the committee is Joseph Watson and William "Bill" Pupkis.

The dam committee through their hard work and dedication received a grant through the Penobscot Estuary Mercury Remediation Trust to install a new and improved fishway and save the historical damn plus maintain access to water for our fire departments at little cost to the town.

Dear Friends:

It is an honor to represent Maine in the United States Senate, and I welcome this opportunity to share several key accomplishments for our state from the previous year.

As Vice Chair of the Appropriations Committee, I have secured nearly \$580 million for 230 projects across all of Maine's 16 counties to promote job creation, workforce training, and economic development; expand access to health care; support law enforcement; improve public education and infrastructure; and protect our environment. As the new Congress begins, I am honored to be taking the helm of the Committee, the first Mainer to do so in nearly a century, and I remain committed to ensuring that federal spending produces real results for our state and nation.

Maine has the oldest average age in the country, which is why I have long prioritized health-focused legislative efforts. There were more than 1,860 health care bills introduced during the 118th Congress. Only 15 health care bills were signed into law, and I was a lead sponsor of five of them. These bills will enhance care for individuals with Alzheimer's, autism, and substance abuse issues through improved research funding, strengthened public health programs, and increased support for rural first responders.


Another important bill that I coauthored was the *Social Security Fairness Act*. Since 2003, when I led the first-ever Senate hearing on the Windfall Elimination Provision and the Government Pension Offset, I have sought to end these provisions of the *Social Security Act* that unfairly reduce the Social Security benefits that public employees or their spouses have earned. I am pleased to say that with the passage of my bill, the *Social Security Fairness Act*, in December, public sector retirees will now receive the full Social Security benefits they have earned.

When the Maine way of life was under threat, I was certain to defend the interests of our state. I worked to protect Maine's potato farmers when the Department of Agriculture tried to reclassify the potato from a vegetable to a grain. I thwarted efforts to consolidate USPS mail operations at the Hampden postal facility, which would have disrupted mail delivery throughout our state. I sounded the alarm with leaders at the FBI and Departments of State and Treasury on the spate of illicit marijuana growing operations that are destroying properties and providing refuge to foreign criminals in our state. Following damage to our working waterfronts after last winter's storms, I secured \$15 million to help fishing communities recover. I championed funding to support the Maine Air National Guard base, Bath Iron Works, and Portsmouth Naval Shipyard.

As of last December, I have cast more than 9,100 consecutive votes, continuing my record of never missing a roll-call vote since my Senate service began in 1997. My ranking as the most bipartisan Senator reflects Maine's tradition of working with a spirit of cooperation and respect.

Dear Friends,

I hope this letter finds you well. It's an honor to continue serving as your representative in Congress, and I take the responsibility very seriously. Thank you for the opportunity to share an update on the work I've been doing for the people of the Second Congressional District.

Fisheries: This spring, the Atlantic States Marine Fisheries Commission (ASMFC) announced a gauge increase for lobsters caught in the Gulf of Maine beginning in January 2025. Maine fishermen warned that this decision is founded on incomplete and inaccurate data. Additionally, this gauge increase could put Mainers at a competitive disadvantage to Canadian fishermen with looser regulations. That's why I sent a [letter](#) to the ASMFC urging them to delay their decision until they can evaluate data with fishermen, whose proactive stewardship provides invaluable insight. I have also submitted an amendment to this year's funding bill that would block federal funding from being used to implement and enforce a gauge increase. Because of these efforts, the ASFMC made the decision to delay the implementation of this new requirement. I'll always stand with Maine lobstermen against unfair, unnecessary regulations that threaten their livelihoods and industry.

Veterans: The first meeting I attended as an elected official was with a large group of veterans and the former Director of the Maine Bureau of Veterans Services. We discussed a lot, but one issue rose above the rest: how little was being done for Maine veterans who needed treatment for mental health issues or substance use. At the time, there were no in-patient treatment beds in Maine, so veterans had to wait for a bed to open up at an out-of-state facility. Fast forward 10 years, through unending red tape, and I'm delighted to report we just broke ground on a treatment facility at the Togus VA Medical Center in Augusta. This was the direct result of the tireless advocacy of veterans from across our state — this win is theirs.

Postal Service: This spring, the U.S. Postal Service (USPS) announced plans to consolidate and move some processing operations from the Eastern Maine Processing & Distribution Center in Hampden to Scarborough. This would have caused significant mail delivery delays that disproportionately harm rural communities. That's why I introduced the *Timely Mail Delivery and Postal Services Protection Act*, which would have halted this planned consolidation across


the country. Following these efforts, the USPS announced they have scrapped their plan entirely. While this is a win for Maine, it is also evidence that we cannot become complacent. That's why I recently introduced the bipartisan *Postmaster General Reform Act*, which would establish term limits for the United States Postal Service's (USPS) postmaster general and require nominations to be confirmed by the Senate.

Regardless of the year, one of my top priorities is ensuring I'm accessible to you. My staff and I can help navigate federal programs; find resources in Maine; and resolve issues with Medicare, Social Security, the VA, and other federal agencies and programs. We are here to help:

Citizens of Waldo County,

The Members of the Waldo County Sheriff's Office are proud to provide law enforcement, correctional and civil paperwork services to the citizens of our great county and we want to thank the members of the public for their continued support.

In 2024, our patrol division handled 7,536 calls for service. These calls included all types of incidents from domestic violence, robberies, burglaries, thefts, child abuse, sexual abuse, drug overdoses, and much more. During 2024, to increase traffic safety, the Sheriff's Office shifted greater focus on traffic safety, including the assignment of a deputy sheriff specifically to traffic enforcement. The increased focus on traffic safety resulted in a significant increase in traffic stops from an average of around 1,500 stops annually to 2986 stops in 2024.

Our corrections division finished its fifteenth year in the operation of our 72-hour intake and the Maine Coastal Regional Re-entry Center. The seventy-two-hour holding and booking facility processed 835 people who were arrested in Waldo County by all the law enforcement agencies serving our County.

In 2024, the participants of the reentry provided 3,375 hours of community service throughout Waldo County. This translated to a savings in labor costs of \$49,443 to citizens and non-profit agencies. Residents also provided more than 32,000 pounds of fresh vegetables to local food pantries and those in need from the County's Garden Project. The residents also paid \$10,566 in room and board to the County and \$5,799 toward their fines and restitution.

Our Civil Service Division served 1,123 sets of legal paperwork all over the county in 2024.

It has been an honor for all of us to be of service to the citizens of Waldo County in 2024. It is my goal as Sheriff to focus the resources of the Sheriff's Office on enhancing traffic safety, addressing substance abuse, and identifying operational efficiencies and cost savings in our correctional services. These issues are critical to the quality of life of everyone in Waldo County. We look forward to providing the citizens of Waldo County with professional law enforcement services based on our core values of Integrity, Teamwork and Compassion. We wish everyone a safe and productive 2025.

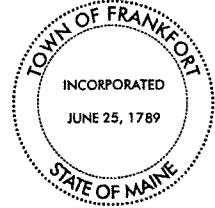

In 2024 our department responded to 66 emergency calls. 16 of those calls were mutual aid calls. If you have an emergency, please remember to dial 911.

We are still accepting new members who would like to join our fire department. Please let one of our department members know if you have any interest in becoming a member or by stopping by when we are at the fire station. There are many different jobs people can do to help at an emergency scene or around our fire station.

We received a matching grant from the Maine Forest Service to purchase two portable radios and four voice pagers. We applied for the AFG Grant in 2024, but unfortunately we were denied. We applied again this year for new turnout gear, air packs and air bottles.

In August we had a courtesy inspection from Maine Department of Labor's SafetyWorks. They found a few minor issues that we corrected. We are on the probationary list to be put on the "SHAPE" Safety and Health Award for Public Employers Program hopefully in mid-2025. Our fire department has started a Health and Safety Committee that meets throughout the year.

We had a busy year working around the fire station, on equipment and on trucks along with training. We have done monthly and annual training and equipment tests throughout the year.

Our annual plant sale this year will be May 8-10 at our fire station. We are hoping for another huge turnout this year.

In September 2024, we attended the Maine State Federation of Firefighters Convention in Waterville. We entered our 911 memorial float in the parade and won first place for fire department floats.

I want to personally thank everyone that volunteered their time and equipment to help us around our station or that have made donations. There are a lot of man hours that goes into training, emergency scenes, and maintenance on the building, equipment and trucks as well as fundraising which is greatly appreciated.

We held a Fall cookout and a Christmas party for our department members and their families to show our appreciation for everything they do for us. We also would like to thank all our surrounding fire departments, Maine Forest Service and the citizens and businesses of Frankfort and other surrounding towns for their continued support. We would like to thank everyone who supports our fundraisers, especially our annual plant sale that is held in May.

As of October 25, 2023, the Maine Forest Service has changed the rules on recreational campfires. If you have a campfire that exceeds 3 feet in diameter on the ground at the base of the fire or exceeds 3 feet in height, you now need a burning permit.

Burning permits are available at Mandy's Country Store, from Jeffery Anderson at (207) 745-0213, Joe Watson at (207) 223-5266 or online at www.wardensreport.com or www.MaineBurnPermit.com. Special thanks to Mandy's Country Store for issuing burning permits. Remember burning permits are required by law to do any open burning.

We would like to remind everyone to post their address number on their house or business and next to their driveway so emergency responders are able to find your home or business in case of an emergency.

WEST FRANKFORT FIRE DEPARTMENT

The West Frankfort Fire Department responded to numerous calls in 2024 from fighting fires, traffic accidents and assisting with EMS on ambulance calls when needed.

We still have our own Hazmat trained team. We continue to train to be prepared for any situation that we may encounter. We also have annual Bureau of Labor Standards training that are mandated for all fire departments.

With the high cost of everything that has to do with fire department related items we apply for various grants to help with the costs. Grants usually come with fire department share from 5% to 60% depending on the grant.

We were very fortunate to have received a FEMA grant for self-contained breathing apparatus (SCBA) for \$130,000.00. Our share of the cost was 5% of the amount. We are also trying to get eight (8) sets of turnout gear replaced on grant money under NFPA. All turnout gear (coats, pants, gloves, helmets, and boots) needs to be replaced every ten (10) years or sooner due to wear or damage. All turnout gear has to be inspected annually.

Our air compressor needs an annual inspection for air quality. The compressor is used to fill our SCBA bottles after use. Records have to be kept on each bottle. Bottles need to be hydro-tested every five (5) years and replaced after fifteen (15) years. Flow tests are required on all SCBA annually and repaired if necessary.

Driver training is required each year, unless Class A licenses. Individuals who are SCBA certified need medical clearance and fit test annual before wearing SCBA according to age of wearer. All fire departments are mandated to follow NFPA and Bureau of Labor Standards.

TOWN OF FRANKFORT ROAD COMMISSIONER REPORT 2024

This past year road work was done on Marsh Stream Road, ditching and was shimmed and over lay was applied to the section by the cemetery, ditching was done on Tyler Lane and gravel was added to dirt roads when we graded them. Culverts were changed on Old Belfast Road and Old Stage. Trees that were falling in to the road on the lower end of Mount Waldo Road were removed.

The plan this year is to pave, but unsure on which road. First, we need to find the cost for paving this year and what road needs it the most. Last year the section on Marsh Stream Road, about half a mile, that was paved cost \$47,000.00. The budget this year for paving is \$100,000.00, which sounds a lot but it will barely do a mile.

Special thanks to the snow plowing crew who have kept the roads safe and to the fire departments for helping out during rain and wind storms with down trees and flooding and to Heather for all that she does to make my job easier.

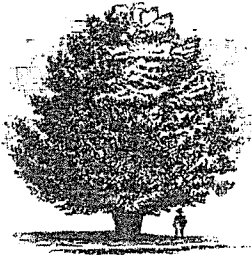

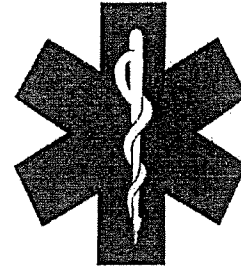

To the Frankfort Select Board,

In 2024, we had a busy and productive year, responding to a total of 501 calls, 140 of which were in Frankfort. When I assumed the role of Chief, I set several key objectives for my first year, which included: increasing staffing to reduce the number of open shifts, enhancing public engagement, and ensuring that our team had the necessary equipment to provide high-quality care in Frankfort. I am pleased to report that we made significant progress in all three areas in 2024.

Staffing and Coverage Improvements

In 2024, we experienced a staffing boost, particularly with EMS providers, which resulted in a 10% increase in coverage compared to 2023. In 2023, we were able to cover only 78% of our monthly shifts; however, in 2024, we improved this coverage to 88%. This trend of improvement has continued into 2025, with only one open shift reported for both January and February, resulting in a projected 98% coverage rate for 2025.

Public Engagement and Transparency

My second goal was to enhance our public visibility, both in-person and via social media. This initiative aimed to increase transparency regarding our staffing, call volume, as well as to engage more actively with the community. We achieved this by regularly posting our monthly response numbers and featuring member profiles on our Facebook page. Additionally, we participated in several community events in Frankfort, including the Easter Egg Hunt, the 4th of July Parade, and Trunk or Treat for Halloween. We also collaborated with the Village and West Frankfort Fire Departments for joint training, which included a CPR class and training on equipment use and patient handling.

Equipment Inspection and Maintenance

The third objective was to conduct a thorough inventory and inspection of our equipment to ensure that our team had the necessary tools to effectively respond to emergencies in Frankfort. This involved repairing the turbo in Ambulance 2 and installing studded tires on both ambulances. Additionally, we increased our backstock of non-expiring supplies and managed our inventory of expiring supplies to reduce waste and ensure readiness.

Goals for 2025

Looking ahead to 2025, we aim to continue building on the progress made in 2024. This includes maintaining staffing improvements, expanding our public engagement efforts, and further enhancing training initiatives, both internally and with the Village and West Frankfort Fire Departments.

Budget Request for 2025

As discussed previously, we are requesting the same budget allocation for 2025 as in 2024, amounting to \$74,182. This funding will be crucial for retaining our current providers and ensuring that our wages remain competitive within the industry.

The Swan Lake Association sincerely appreciates the support of the Towns of Swanville, Searsport and Frankfort the lake. In the 2024 season, property owners along Swan Lake continued to enjoy the very stable lake levels because of the new dam gates. The new docks at the boat ramp, placed last spring allowed easy access to boats that are launched and retrieved, as well as access to boats for mobility impaired people.

The main goal of the Swan Lake Association is to preserve the pristine waters of the lake. We continued and expanded our Courtesy Boat Inspection program this year, with more hours and more days of coverage. We found that the new dock has increased the use of the boat ramp for daily pleasure craft necessitating coverage into the afternoons on nice weather days.

In 2024, association members, proposed a new boat ordinance to the Town of Swanville to limit overnight stays on boats such as houseboats. The docks have made it possible to enter boats of this design but as there is no marina on the lake offering both safe refueling and sewage pump out, having overnight boats on the lake like this could lead to fuel spills and sewage dumps, which would have a direct and harmful impact to the water quality. A significant number of property owners draw their domestic water supply from the lake. Association members also met with the Select Boards of Searsport and Frankfort, requesting that they also consider adopting the same ordinance at Swanville to provide consistency around the lake.

The association placed picnic tables at the dam area for use by the public that visits the dam area for swimming and recreation. We also placed and maintain a trash can at the boat ramp to supplement the portapotty we supply. We maintain the boat ramp area with mowing and clean up and remove and replace the boat ramp docks and marker buoys in the lake.

The Swan Lake Association is an entirely volunteer organization. Other than payroll for our hired Courtesy Boat Inspectors, related insurance and mailing our annual newsletter, we have no administrative costs. We rely entirely on the generosity of members as well as the grants we receive from the Towns around the lake and others.

The Town of Frankfort has provided a grant to the Swan Lake Association in the past. We respectfully request that the town consider renewing that grant for 2025. The previous grant was in the amount of \$500. In 2024, Swanville granted \$2500 and Searsport \$1200. Thank you for your consideration.

We appreciate your continuing support.

1A WALDO COUNTY BROADBAND COALITION

Dear Neighbors:

The past year has been a busy one for our efforts to improve internet service in town by bringing affordable, reliable high speed broadband to every residence. Many of you continue to contact us with your concerns and challenges about poor connectivity – whether it's no service at your home, slow or unreliable connections via satellite or outdated cable, or unaffordable bills. The abrupt end of service through AC Networks was a particular disruption for many this year. We are working diligently to address these challenges and appreciate your patience, support, and creative ideas.

As you may recall, Frankfort is working collaboratively with Prospect, Stockton Springs, and Winterport through a committee we call the 1A Waldo County Broadband Coalition. You can stay up to date on our activities by visiting <https://1awaldobroadband.com/>. We issued a competitive request for proposals to establish a public-private partnership with an internet service provider to bring fiber broadband to our towns, and as a result have been working with Direct Communications (formerly UniTel, Inc.). Working with Direct Communications, we applied for multiple grants this year from state, federal, and philanthropic sources.

While all were competitive and several were unsuccessful, we are pleased to report an award of \$3.6 million through the Maine Connectivity Authority's Partnerships Enabling Middle Mile program was made to our coalition last August. With additional matching funds provided by Direct Communications and each town – Frankfort contributed ARPA funds, not municipal tax dollars – this grant will produce a total investment of \$5.5 million in our region, and will build a “backbone” of fiber that will connect more than 1,100 locations in the 1A towns. To build the remaining network to reach every unserved location, Direct Communications has applied with our support for additional funding through the BEAD program, which is federally funded and administered by the Maine Connectivity Authority. That funding is expected to be awarded later this spring, barring any federal changes.

Direct Communications is currently conducting permitting work and will begin construction later this year, with the build on poles complete by the end of 2026 and ongoing work to connect customers who sign up. You can determine whether you will have access to the service by visiting <https://register.directcom.com/> and entering your address. You can preregister for service at that website as well. Direct Communications provides affordable fiber internet, with plans as low as \$29.95 per month for 300 Mbps, and speeds as high as 2 Gigs.

We are also aware that Fidium, a Consolidated Communications company, is building out fiber to parts of Frankfort. You can check if this service is available to you on their website. It's possible that eventually some locations may have access to service from both providers, increasing competition for your business!



Mooring Regulations Ordinance Town of Frankfort, Maine

Section 1: Title

This ordinance shall be known as the "Town of Frankfort Mooring Regulations Ordinance."

Section 2: Authority

This chapter is adopted pursuant to the enabling provisions of Article VII, part 2, section 1 of the Maine Constitution and the provisions of 12 M.R.S.A. §13072, 30-1 M.R.S.A §3001, and 38 M.R.S.A. §1 to 13.

Section 3: Purpose

These standards are designed to ensure that mooring installation, use, and maintenance does not impair the public health, safety, and welfare; does not result in degraded water quality, loss of aquatic habitat, or interface with navigation; or does not infringe on the rights of shoreland property owners.

Section 4: Applicability

This regulation allows the installation of mooring for the purpose of securing a watercraft, float, float plane, or swim area floats in a great pond or stream within the Town of Frankfort. The same regulations also apply to anchoring.

Section 5: Conflict and severability

- A. Conflict with other ordinances. Whenever a provision of this regulation conflicts with or is inconsistent with any other ordinances, regulations or statute, the more restrictive provision shall apply.
- B. Severability. The invalidity of any part of this regulation shall not invalidate any part of this regulation.
- C.

Section 6: Definitions

1. Great pond: Any inland body of water which naturally has a surface area over 10 acres.
2. Mooring: Any device to float and is attached to the anchoring device that secures a watercraft, float plane or swim area floats to the bottom of a water body.
3. Mooring Location: A rectilinear area on a body of water in which the master or owner of a boat, float or vessel has been permitted to place a mooring.
4. Anchoring: To hold fast by means of an anchor.
5. Watercraft: Any craft meeting the federal or state definition of a watercraft.
6. Shorefront Mooring Zone: The area of water within two hundred (200) feet of the normal high-water line, or one third (1/3) the distance to the opposite shore's normal high-water line, whichever is less.
7. Float: A floating platform moored or anchored for use by the swimmers or boats, that is not integrated and connected with a deck.
8. Beam: A watercrafts side-by-side measurement at its widest point.
9. Head: A toilet or lavatory in or upon a watercraft.
10. Galley: A kitchen or an area with kitchen facilities in or upon a watercraft.

Section 7: Shoreland Mooring Zone

Mooring placement shall be the responsibility of the property owner subject to the following conditions:

1. A mooring may be placed by a shorefront property owner or another individual with the shorefront property owner's written permission.
2. A mooring shall be placed in the shorefront mooring zone directly adjacent to the owner's property.
3. The mooring shall be restricted to the water within two hundred (200) feet of the normal high-water line, or one third (1/3) or the distance to the opposite shore's normal high-water line, whichever is less. If a mooring is deemed to create a navigation hazard, it shall be removed or moved to a safe mooring location specified by the CEO.
4. There shall be no more than one mooring for every fifty (50) feet of shoreline of each property.
5. A mooring shall not be allowed if watercraft attached to it will interfere with the watercraft attached to other lawful moorings and/or swim area floats, or if safe navigation is impeded. Anchoring must also not impede safe navigation.
- 6.

Section 8: Overnight Mooring, Anchoring, Tethering, or Docking

The overnight mooring, anchoring, tethering, or otherwise securing of water vessels is prohibited on Swan Lake if the watercraft possesses the following characteristics:

1. The watercraft has a flat main deck with a beam of seven (7) feet or greater.
2. Additionally, the watercraft as above its main deck a superstructure that contains a head and/or a galley and/or sleeping quarters designed or modified for temporary or permanent living. This regulation does not prohibit overnight stays on personal watercraft that do not meet this definition, as long as the craft is anchored, moored, or secured with two hundred (200) feet of shore, or tethered to a dock with the owner's permission, and does not impede safe navigation.

Section 9: Harbormaster

1. The Selectboard shall appoint a harbormaster to carry out and enforce provisions of his/her chapter. The harbormaster shall be appointed for a term of no less than one year in accordance with the requirements of 12 M.R.S.A §13072 and this chapter. The town's code enforcement officer may also serve as its harbormaster.
2. The municipal officers of two (2) or more municipalities that border on the same inland waters may jointly appoint a single harbormaster who has authority over the jurisdictions of all the participating municipalities.

Section 10: Enforcement; Violation and Penalties

- A. The harbormaster shall determine whether provisions of this chapter have been violated. The selectboard, together with the harbormaster, shall assess the nature and severity of the violation and shall take necessary course of corrective action, which may include assessment of penalty. If an illegally placed mooring is not removed within fourteen (14) days after notice of violation that has been sent by certified mail and regular United States mail to property owner's address as listed in the town's property tax commitment book, the harbormaster may remove the mooring. The mooring owner shall be responsible for all expenses incurred in the removal, including fees.
- B. Any person who violates any provision of this chapter shall be subject to a civil penalty of not less than one hundred (100) dollars and not more than \$2,500.00 for a first violation. The violator may be ordered to correct or abate the violation unless the court finds that such action will create a threat or hazard to public health and safety, substantial environmental damage, or

substantial injustice. Each day that such a violation continues to exist shall be considered a separate violation. This chapter shall be enforced pursuant to 30-A.M.R.S.A. §4452. The failure to obey the lawful order of a harbormaster shall be punished as a Class E crime pursuant to 38 M.R.S.A. §13.

Section 11: Appeals

Appeals by any person aggrieved by a decision, act, or failure to act by the harbormaster as it related to the implementation and enforcement of this chapter shall be made to the Appeals Board. In al cases, a person/or persons aggrieved by an order or decision made or failure to act by the harbormaster shall file his/her appeal with fourteen (14) days of receipt of notice of the action. The town clerk shall notify the selectboard, the town manager, the harbormaster, and the Appeals Board of the appeal. The Appeals Board will apply an appellate standard review in a search for errors or inconsistencies supported by the evidence.


Section 12: Effective Date


